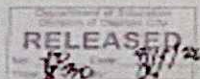

1. Relative to Republic Act 10157, titled, "Kindergarten Education Act of 2012 which emphasizes developmentally appropriate play-based learning. DepEd Order No. 47 series 2016 re: "Omnibus Policy on Kindergarten Education", Early Childhood Education is a critical period for building foundational skills in literacy, literacy and writing and the continuous effort of this office through the Curriculum Implementation Division will conduct a two-day Division Training Workshop on Enhancing of Untrained School Heads and Kindergarten Teachers' Competence in Content and Pedagogy held on May 7-8, 2026. Venue will be announced later.

2. The training-workshop aims to:

- 2.1. enhance participants' understanding of early childhood education and Kindergarten Education Program including its goals and policies;
- 2.2. strengthen teachers' competence in kindergarten curriculum content and learning competencies;
- 2.3. equip school heads with strategies for instructional supervision and support for kindergarten teachers;
- 2.4. enhance teacher's skills in designing developmentally appropriate learning activities aligned with learning activities;
- 2.5. break down (unpack) MATATAG competencies into clear, simple, measurable learning objectives align to the target MATATAG competencies;
- 2.6. design play-based activities align in the select competencies per week;
- 2.7. demonstrate appropriate teaching strategies for each block of time using play-based and child-centered approaches.

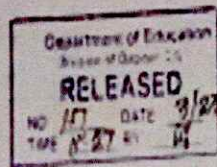
