SUBJECT: IMPLEMENTATION OF THE SCHOOL-BASED FEEDING PROGRAM (SBFP)
USING FISCAL YEAR (FY) 2022 FUNDS

DATE : APRIL 29, 2022

- Pursuant to DepEd Order No.10 s. 2021 entitled SUPPLEMENTAL GUIDELINES ON DEPED ORDER NO, 031, S. 2021, This Division will deliver Nutritious Food Products good for **30 feeding days** and **16 feeding days** for Pasteurized/Sterilized Milk Packs to designated drop off points of Schools Division of Dapitan City on May 16,2022.
- In connection with this, all Elementary School Heads and School Feeding Coordinators are advised to bring big environment - friendly bag that is suitable to the food packs allocation of their school and also ice chest/insulated coolers for Milk packs at their designated drop off points for distribution to SBFP - NFP Component beneficiaries on May 16, 2022.
- In this supplemental guideline on the specific provisions of DepEd Order (DO) No, 031. S. 2021 shall be followed:
 - Section II, Scope and Coverage
 - On A.2 Primary Beneficiaries
 - The SBFP primary beneficiaries shall be the same beneficiaries in SY 2021-2022 using FY 2021 (all Kindergarten learners and SW and W in Grade 1 to 6 learners)
 - On B. Duration
 - The number of feeding days shall be 30 days for Nutritious Food Products (NFP) and 16 days for Pasteurized/Sterilized

Milk Packs (PM/SMP) and the suggested implementation period is within April to July of SY 2021-2022 both for NFP and milk component.

b. Section XI. Other Activities

i. On A. Nutritional Assessment

(I) Nutritional assessment may be conducted in May - June 2022 to established the nutritional status of beneficiaries at the end of feeding period subject to issuance of a memorandum depending on the community quarantine status.

4. The repacking of nutritious food products, personnel must adhere to food safety standards and the required health standards such as handwashing before handling food products, wearing of masks, gloves and practice of physical distancing.

5. The food safety standards, in accordance with DepEd Order No. 52 s. 2008, or Compliance with DepEd Policies on Food Safety in Schools, shall be followed by the SBFP implementers at all times.
