"A RESOLUTION EXPRESSING THIS AUGUST BODY'S STRONG SUPPORT TO THE CINEMALAYA FILM FESTIVAL 2022 IN DAPITAN CITY AND URGING THE SANGGUNIANG KABATAAN FEDERATION, THE LOCAL YOUTH DEVELOPMENT OFFICE, THE JOSE RIZAL MEMORIAL STATE UNIVERSITY, DEPED-DAPITAN CITY, DEPED-ZAMBOANGA DEL NORTE AND ALL BARANGAY OFFICIALS AND ELECTED OFFICIALS OF THE CITY, AS WELL AS ALL THE DEPARTMENTS OF THE LOCAL GOVERNMENT UNIT OF DAPITAN CITY, TO ACTIVELY PARTICIPATE IN ALL THE ACTIVITIES ALIGNED WITH CINEMALAYA FILM FESTIVAL."

WHEREAS, this year 2022 **Cinemataya** is the longest running and most influential independent film festival premiers to be held in Dapitan City, the country's merging heritage tourism and art destination;

WHEREAS, **Cinemataya 18 in Dapitan** is the festival of winners, scheduled on September 9 to 13, 2022, in partnership with the **Cinemataya Foundation, Cultural Center of the Philippines, Zanorte Tourism Council, City Government of Dapitan, Dapitan Culture and Arts and Heritage Council and ROMGARJAL Group of Companies;**

WHEREAS, the winning films of the **Cinemalaya 18 Festival 2022** and the special screening of the selected titles will be shown in the premier, wherein the same will be attended by film makers, actors and Festival Executive;

WHEREAS, the project objective of the Cinemalaya 18 Dapitan Festival of winners aims to stimulate the formation of a film appreciation society in Dapitan, among youth and the local industry, as well as to introduce Dapitan City to the film industry as a place for film production starting with the consultation of the local and national stakeholders on the formation of DAPITAN FILM COMMISSION;

WHEREAS, on September 9, 2022, there will be a festival opening party with the mayors/governors, a dinner and the heritage tour, along with the Red Carpet of the Stars with the presence of the winning directors of the Cinemalaya Film Festival 2022 and also their actors and actresses;

WHEREAS, it was also revealed that a winning piece was chosen with the Youth as the recipient for the screening, entitled: "Baseball Player," which will be shown in Teatro de Dapitan;

WHEREAS, with this development, the doors of Dapitan City may be open for more opportunities in the Tourism Industry, thus this August Body strongly supports the Cinemalaya Film Festival, 2022 and considers the same beneficial to the Local Government Unit of Dapitan City and the Provincial Government of Zamboanga del Norte, more particularly to the youth sector as well.

WHEREFORE, premises duly considered, be it




