SUBJECT: CONDUCT OF ELECTION OF SCHOOL-LEVEL PARENT-TEACHER

ASSOCIATIONS FOR SY 2022-2023

DATE: **September 16, 2022**

- 1. Pursuant to DepEd Order No. 013, s. 2022 re: Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations, also known as the "Omnibus PTA Guidelines of 2022," all public, private, and non-DepEd managed basic education schools shall organize school-level Parent-Teachers Associations (PTAs) within thirty (30) calendar days from the opening of classes to provide a forum for the discussion of issues and their solutions to the total school program and to ensure the full cooperation of parents/guardians in the efficient implementation of programs.
- 2. Following DepEd Order No. 013, s. 2022, schools shall organize three school-level Parent-Teachers Associations, to wit: (1) Homeroom PTA (HPTA), (2) Grade Level PTA (GrPTA), and (3) School PTA (SPTA, formerly known as General PTA) anytime from August 22 to September 22, 2022. The list of SPTA (BOD/EXECOM) officers shall be submitted to the School Governance and Operations Division - Social Mobilization and Networking Section on or before September 30, 2022.
- 3. School who have already conducted elections shall make arrangements to ensure adherence with this new guidelines.
