Pursuant to DepEd Order No. 29, s.2019, a joint circular with DBM and COA, the DepEd SDOs/Ros are mandated to reconcile the amount withdrawn based on the bank statement or passbook with the reported disbursement and the supporting documents submitted for liquidation of the school MOOE cash advance.

The Department of Education (DepEd) likewise adheres to the rules and regulations presented in the Volume 1 Chapter 21 of the Government Accounting Manual (GAM) prescribed by COA pursuant to Article IX-D Section 2 par. (2) of the 1987 Constitution of the Republic of the Philippines.

In this regard, this division will conduct a "Bank Reconciliation Seminar-Workshop" for the school and district non-teaching personnel and designated disbursing officer in accordance with their identified learning and development needs and to enable them to perform their functions effectively.

The objectives of this activity are:

- 1. To train participants in checking the correctness of both the banks and school's records,
- 2. To develop the skills of the participants in preparing BRS and in deterring fraud; and
- To enable the agency /school or bank to take up charges or credits recognized by the bank or agency/school but not yet known to the agency/school or bank.
