ADDENDUM TO DIVISION MEMORANDUM NO. 142, s. 2023, TITLED, "DACAA DELEGATION COMPOSITION FOR THE 2023 ZPRAA QUALIFYING MEET"

Chiefs, CID and SGOD To: PSDSs, PICDs Private and Public Elementary and Secondary School Heads All Concerned Coaches, Chaperons, Athletes This Division

- 1. A meeting of all committee chairmen, Head Coaches and other key DACAA officials shall be conducted on April 12, 2023 at 2:00 o'clock in the afternoon at the Division Office Conference Hall. The list of participants of this meeting is found in Annex A of this memo.
- 2. There will be a 7 days conditioning training of all qualified athletes to be held on April 15-21, 2023 at the Dapitan City Experimental Elementary School. All athletes are advised to bring their own sleeping and eating paraphernalia and expected to be in the venue at 10:00 o'clock in the morning on April 15, 2023.
- 3. Screening of the documents of athletes, coaches and chaperons shall start on April 17, 2023 at the Dapitan City Experimental Elementary School.
- 4. The advance party shall leave for Pagadian City on April 21, 2023. The Advance Party Composition is found in Annex B.
- 5. The Third Quarter Examination of all athletes shall be administered on April 13-14, 2023. All Teachers involved in the screening, training of athletes and the actual ZPRAA participation shall make necessary arrangements with their school head and co-teachers to avoid disruption of classes on affected class schedules.
- 6. All teachers rendering services as coaches, chaperons and members of the committees during Saturdays, Sundays and Holidays in relation to the training of athletes, preparation and actual participation to the ZPRAA Meet shall be granted service credits while Compensatory Overtime Credits for Non-Teaching Personnel, subject to the existing rules and regulations on the grants of service credits.
- 7. Widest and immediate dissemination of this memorandum is desired.




