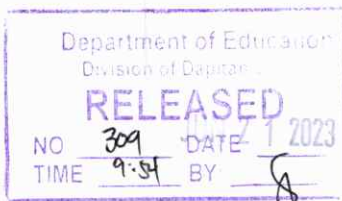

4. Immediate dissemination of this memorandum is desired.

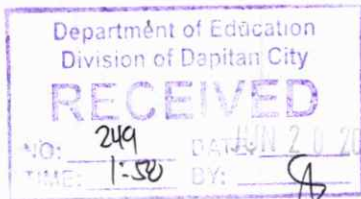

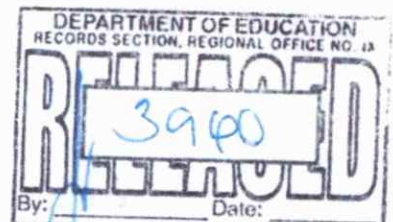

It has come to the attention of this office, the numerous complaints, concerns and issues pertaining to extravagant preparation and spending for the coming end-of-school-year rites and activities which include among others graduation exercises, moving-up ceremonies, graduation balls and other similar activities.
2. Please be reminded that the Department has issued the attached DepEd Order No. 009, s. 2023 regulating the aforesaid activities to prevent extravagance and overspending.
3. Specifically, said order highlighted the prevention on excessive spending, extravagant attire, extraordinary venue for the conduct of either graduation and moving-up ceremonies and other related activities.
4. In view of the foregoing, the division management through their Education Program Supervisors and Public Schools District Supervisors who are taking in-charge of the school monitoring activities are directed to give special attention to these cases to avoid possible escalation.
5. Widest dissemination of and compliance with this Memorandum is desired.
