The Philippine Commission on Women - North Mindanao Field Office is conducting the Safe Spaces Act and Prohibition on Child Marriage Law Orientation and Workshop Caravan in Region IX, as part of our efforts to advocate and promote gender equality and women empowerment at the provincial, city, and municipal level.

RA 11313 or the Safe Spaces Act (SSA) was signed into law on April 17, 2019 and took effect on August 3, 2019, but the COVID-19 pandemic has hindered the widest dissemination and awareness raising of the law. RA 11596 or the Prohibition Against Child Marriage Law was signed into law more recently, on December 21, 2021.

This orientation and workshop caravan aims to provide GAD Orientation refresher to participants, to raise awareness on RA 11313 and RA 11596, and to encourage localization of the laws in the LGU. The target locations and dates of the five (5) legs are the following:

Leg 1:	Pagadian City	August 9-11, 2023
Leg 2:	Dipolog City	August 23-25, 2023
Leg 3:	Zamboanga City	September 6-8, 2023
Leg 4:	Zamboanga City	September 12-14, 2023
Leg 5:	Ipil, Sibugay	October 4-6, 2023
