1. In line with Regional Memorandum No. 560, s. 2023 dated October 26, 2023 re: Administration and Submission of Beginning of the School Year Reading Assessment Data, this Division, through the Curriculum Implementation Division, shall conduct the Beginning of School Year (BOSY) Reading Assessment Data of the schools in the District Offices as stipulated in DepEd Order No. 22, s. 2023, otherwise known as the Implementing Guidelines on the School Calendar and Activities for the School Year 2023 – 2024.
2. The Philippine Informal Reading Inventory (Phil-IRI) is a classroom-based assessment tool which aims to measure and describe the learners' reading performance in both English and Filipino languages in oral reading, silent reading, and listening comprehension. These three types of assessment aim to determine the learners' independent, instructional and frustration levels.
3. The Comprehensive Rapid Literacy Assessment (CRLA) is a start-up assessment which helps identify each child's reading profile. It will tell who is on track and who needs to review concepts from the previous grade.
4. This undertaking has the following objectives:
 - a. to review, analyze, and utilize the BOSY Reading Assessment Data submitted by School District Offices;
 - b. to apply the CRLA to evaluate students' progress and identify those who may need additional help;
 - c. to use the Phil-IRI as a tool for assessment students' reading abilities in English and Filipino, aiming to determine their reading levels;
 - d. to provide data for the National Reading Program activities, Regional/Division Development Plan and other inter-agency reports; and
 - e. to monitor the quality of interventions and activities aimed at addressing learners' reading difficulties.

The District Offices through the PSDSs/PICDs shall submit to this Office the Consolidated Reports of the BOSY Reading Assessment Results using the CRLA for Key Stage 1 (Grades 1 to 3) and Phil-IRI for Key Stage 2 to 3 (Grades 4 to 10) both in English and Filipino Templates shall be downloaded to avoided glitches.
7. The deadline for submission of the Validated Report shall be on or before December 7, 2023. All consolidated data shall be sent through these e-mail maperga.cadiente@deped.gov.ph for English and lindo.adasa@deped.gov.ph for Filipino
8. All districts are expected to validate the veracity and accuracy of the inputted data. Careful diligence shall be observed. An orientation on the use of consolidated tools shall be given utmost importance.
9. All districts through the Public Schools District Supervisors/Principal In-Charge of the District/s shall ensure that all schools have conducted the CRLA and the Phil-IRI BOSY.
10. Upon finalization of the BOSY data, schools are expected to provide appropriate interventions and sustainability actions to address current school reading profile.
