DUTIES AND RESPPONSIBILITIES OF DepEd PURSUANT TO EXECUTIVE ORDER No. 7, s. 2024 TITLED AN ORDER ORGANIZING THE SMOKE FREE TASK FORCE OF DAPITAN CITY

1. Pursuant to Executive Order No. 07 Series of 2024 entitled: "AN ORDER ORGANIZING THE SMOKE FREE TASK FORCE OF DAPITAN CITY, the following are the Duties and Responsibilities of DepEd as stipulated in Section 2 of the Order:

- A. Implement the Department -Commission Orders on the integration of tobacco control education into the curricula;
- B. Ensure strict compliance of the Memos. and Orders on the protection of the bureaucracy from Tobacco Industry interference as FCTC Article 5.3;
- C. Ensure strict compliance of schools in enforcing 100% smoke free campuses and school facilities including the schools' vehicles;
- D. Assists in the monitoring of tobacco / ENDS products' sales, advertisements and promotion within 100 meters from the perimeter of schools, public playgrounds and facilities frequented by minors; and
- E. Ensure the posting in clear and conspicuous manner "No Smoking" signs and notices for the sales ban of Tobacco Products within 100 meters from the perimeter of schools, playgrounds, facilities frequented by minors and health facilities.
