PARTICIPATION TO 2024 ZANDIDAP COUNCIL YOUTH FORUM

1. Pursuant to the BSP ZANDIDAP Council Office Memorandum No. 1, s. 2024, dated January 3, 2024, entitled "2024 ZANDIDAP Council Youth Forum", with the theme: "Youth Engagement: Sustaining Relevance and Strengthening Resilience", the Boy Scouts of the Philippines, ZANDIDAP Council, Dapitan City Division will participate in the **2024 ZANDIDAP Council Youth Forum** on **January 26-28, 2024** at Florentino T. Daarol Scouts Camp, Compra, Liloy, Zamboanga del Norte.
2. The Youth Forum aims to provide the youth with a means to bridge their thoughts and ideas into the adults' present thinking.
3. Relative thereto all Secondary Schools are advised to send at least two (2) Senior Scouts who are chosen at their respective school to represent in the Forum, which preferably Grade eight (8) or nine (9) scouts.
4. To ensure the success and effectiveness of the participation, this Division created a Composition of the Delegation (See Annex A) to serve, assist, and guide the scouts during the activity.
5. The delegation shall adhere to DepEd Order no. 66, s. 2017 "Implementing Guidelines on the Conduct of Off-Campus Activities" for the safe and secured travel and participation to the event.
6. A Registration Fee of ONE THOUSAND PESOS (Php 1,000.00) to cover for meals & snacks for 3 days, conference materials and others.
7. Registration, travel and other incidental expenses relative to the participation to this activity shall be charged against SEF/Local Funds, PTA Funds, School BSP Sustaining Funds, Local Scout Funds and other sources of funds subject to the usual accounting and auditing rules and regulations.
8. Teacher participants shall receive Service Credits during Saturdays, Sundays and holidays subject to the provision stipulated under DECS Memorandum No. 143, s. 1997. Likewise, School Heads and non-teaching personnel shall be provided with Compensatory Overtime Credit (COC) per CSC and DBM Joint Circular No. 2, s. 2004.
