3. Below is the composition of the DepEd Dapitan ICT Knights:

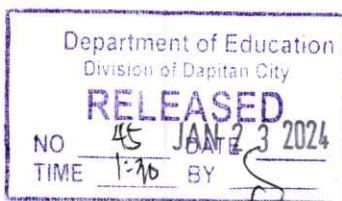
