- 1. Republic Act 10588 Paragraph 2, Sec. 2, Art. 1 states: "Hence, it shall be a declared policy of the State to support programs that will improve and promote the Palarong Pambansa as the primary avenue for providing in-school sports opportunities to improve the physical, intellectual and social well-being of the youth. All educational institutions are therefore directed to promote physical education and undertake regular sports activities as well as support to local meets and the Palarong Pambansa".
- 2. To support this mandate and to establish baseline for talent identification, selection, recruitment and training of athletes in the different sport events for the upcoming higher meets, this division sets the schedule of activities for the schools and districts to observe, to wit;

- 3. Eligibility of the athletes is found in enclosure 2 of DM No. 005, s. 2023 to compete in the lower meets up to Palarong Pambansa.
- 4. Schools which are affected by this activity shall implement flexible learning modality and expected to provide all athletes with learning intervention as part of their academic program and assign teachers to affected classes in compliance with DepEd Order No. 022, s. 2023 and DepEd Order No. 003, s. 2024.
