
II. Schedule of Briefing for All Participating School Paper Advisers in Filipino and English

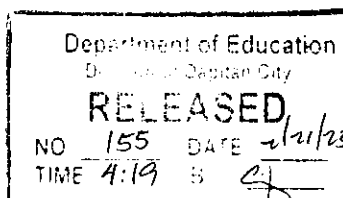
