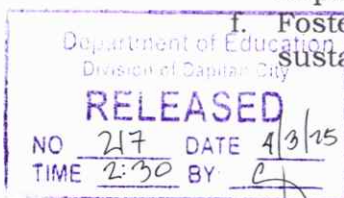

**CONDUCT OF WORKSHOP ON THE MONITORING AND EVALUATION OF THE HEALTH PROGRAMS OF SELINOG INTEGRATED SCHOOL AS A HEALTHY LEARNING INSTITUTION (HLI)**

1. Pursuant to Republic Act 11223 or the Universal Health Care (UHC) Act, schools under the jurisdiction of the Department of Education (DepEd) shall be designated as healthy settings, guided by standards, programs, and modules on health literacy, health promotion, and disease prevention set out by the DepEd and Department of Health (DOH).
  2. The DepEd-Schools Division of Dapitan City in coordination with the Zamboanga del Norte Provincial Health Office Healthy Learning Institution (HLI) Core Team will conduct a **Workshop on the Monitoring and Evaluation of the Health Programs of Selinog Integrated School as a Healthy Learning Institution**, on **April 3, 2025** at **Selinog Elementary School** which is a Last Mile Elementary School (LMES).
  3. The objectives of the activity are the following:
    - a. Equip school personnel with the knowledge and skills to monitor and evaluate health programs;
    - b. Utilize appropriate tools and strategies for effective M&E of school health programs;
    - c. Strengthen the implementation of health policies and practices that promote the overall well-being of students and school personnel;
    - d. monitor the progress of implementation and evaluate whether the Healthy Learning Institution program was able to meet its objectives, to review progress of implementation at the school-level;
    - e. identify key operational issues, enabling and hindering factors in HLI implementation; and
- I. Foster closer coordination between DepEd and DOH in ensuring the sustainability of school health programs.
