**PARTICIPATION OF DACAA ATHLETES AND OFFICIALS IN THE 2025
PALARONG PAMBANSA**

1. Pursuant to Regional Memorandum No. 157, s. 2025, entitled: "Participation of the ZPRAA Delegation in the Palarong Pambansa", DACAA athletes and officials will participate in the 2025 Palarong Pambansa on May 24 to June 2, 2025 in Laoag, Ilocos Norte.
2. Participants to this activity are the private and public elementary and secondary school qualified athletes, coaches, chaperons and officials of different sports events (See Annex A).
3. All qualified athletes shall attend the review and validation of athletic records at SDO, Zamboanga del Norte on April 21-22, 2025.
4. The delegation shall depart on May 16, 2025 at the designated airport and return on June 2, 2025 at Laoag Airport, Laoag, Ilocos Norte.
5. The training of the qualified athletes for team events shall be facilitated by the winning coaches, while the individual events will be facilitated by their respective clubs under the supervision of the school principal and the Division Sports Officer for proper conduct of the training.
6. School Heads shall arrange the affected classes of the athletes, coaches and trainers based on the schedule and matrix of the coaches.
7. To encourage and inspire the participating athletes to the national competition, the grades of selected athletes shall either be retained or improved based on their performance in assessments during the training period, however, their grades shall not be lowered or marked as failing.

8. All graduating pupils, students and candidates for honors may be given an advanced test before reporting to the training venue.

9. Teachers who will served during Saturdays, Sundays and Holidays shall be granted Vacation Service Credits subject to the provision stipulated under DepEd Order No. 013, s. 2024. Likewise, School Heads and non-teaching personnel shall be provided with Compensatory Overtime Credit (COC) per CSC and DBM Joint Circular No. 2, s. 2004.
10. The costs for playing uniforms, food and local transportation during the modular training, as well as the transportation expenses and food incurred by the participants when traveling from their residence to the designated airport for departure shall be charged against Special Education Fund (SEF), School/Division MOOE and other sources of funds, while the travel expenses from the assigned airport to Ilocos Norte including the return trip and all related costs shall be covered by the national funds and the regular MOOE/ROP, subject to the usual accounting and auditing rules and regulations.
