**ADOPTION OF THE SHRINE STRATEGIC FRAMEWORK
AND INTEGRATION INTO PLANNING DOCUMENTS AND BRANDING**

1. In pursuit of empowered, future-ready Dapitanon learners nurtured through inclusive, resilient, and transformative education, the Schools Division of Dapitan City formally adopts the **SHRINE Strategic Framework**. This framework is anchored on the **Quality Basic Education Development Plan (QBEDP) 2025–2035**, the **Basic Education Development Plan (BEDP) 2030**, and the **5-Point Reform Agenda** of the current DepEd Secretary.
2. SHRINE stands for:
 - **S**afe and Supportive Schools
 - **H**olistic Development of Learners
 - **R**esponsive and Resilient Teaching Force
 - **I**nclusive and Innovative Learning Delivery
 - **N**urturing Partnerships and Governance
 - **E**mpowered and Employable Graduates

This framework guides all governance levels (SDO and schools) in attaining its goal of quality basic education, efficient governance, and learner well-being, aligned with national development goal *Ambisyon Natin* 2040 and the Sustainable Development Goals (SDGs).

3. **Policy Directives**

- a. Integration into Planning Documents
 - Schools Division Office (SDO) functional divisions / sections / units and **all schools** shall review, enhance, and adjust their respective Division Education Development Plan (DEDP) and School Improvement Plans (SIPs) to align with the SHRINE Framework and the 5-Point Agenda.

- Starting September 2025, all governance levels (SDO functional divisions and schools) must prepare their **2026 Annual Implementation Plans (AIPs)** and Work and Financial Plans (WFPs) using the standardized templates provided for uniformity and ease of consolidation.

b. Branding and Advocacy

- As approved and ratified during the 1st Division Management Committee Meeting (DivManCom) in July 2025, the Division shall adopt the branding "**Dapitan Shriners**" to reflect the shared vision and strategic direction.
- All official materials including letterheads, advocacy shirts, banners, and communication tools must incorporate the Dapitan Shriners seal/logo.
- Templates, logos, and other materials may be downloaded via this link: bit.ly/SHRINE-Dapitan.

4. **Implementation and Support**

The School Governance and Operations Division (SGOD) and Curriculum Implementation Division (CID) shall provide technical assistance and monitor compliance. Orientation sessions and workshops will be scheduled to support implementation.

5. **Monitoring and Evaluation**

Monitoring and evaluation shall be conducted through the SDO-School Interface, guided by key performance indicators aligned with the SHRINE and QBEDP outcomes. Reports shall be submitted semi-annually to the Division Office.

6. **Effectivity**

This memorandum shall take effect immediately and shall remain in force unless amended or repealed.
